N.B :- i) Also, in the process, 02 vacant revenue charged posts GP-1900/- of M.V.Driver Gr-III have been surrendered and Rs- 1,21,680/- has been saved and will be credited in Vacancy Bank.

N.B :- ii) One (01) post of M. V. Driver Gr-II, G.P Rs.2400/- and Four (04) posts of M. V. Driver Gr-III, G.P Rs.1900/- have already been surrendered due to restructuring of Traffic Asstt. Cadre w.e.f **29-06-2015** vide O.O.No.AU/O&M/PERM/RESTRUCT/01/2015 dated 27-08-2015 and as such above posts are reduced after restructuring of M.V.Driver cadre.

Accordingly Three (03) posts of M.V.Driver Gr-II, GP-2400/- and Two (02) posts of M.V.Driver Gr-III, GP-1900/- will stand reduce w.e.f. 29.06.2015 to balance the matching surrender made for implementation of restructuring of TA cadre w.e.f. 29.06.2015 as sufficient number of posts of M.V.Driver Gr-III, of GP-1900/- (i.e four nos) are not available in the cadre.

iii) On reduction of 02 posts of M.V.Driver Gr-II, in G.P Rs,2400/- , in place of M.V.Driver Gr-III, G.P Rs.1900/- additional savings value comes as under :-
Rs.500/-x 02=Rs.1000/- + D.A Rs.1130/-X12Months = Rs.25560/- and credited in vacancy Bank.
