Sub: Error/mistake in the RBE 93/2016 regarding the pay fixation of Running Staff.
Ref: This Union's letter No.MTP/RMU/TOL/Running Staff(7<sup>th</sup> CPC) dated 03-8-2016.

The Railway Board vide letter under reference circulated some clarification instruction/ order of Railway Service (Revised Pay) Rules, 2016.

In Para 5 of this Railway Board's letter dated 02-8-2016 (RBE No. 93/2016) Board have issued instruction regarding the methodology fixation of the revised pay of the Running staff as on 01-01-2016 wherein it appears that the hike (fitment) of 14.29% of benefit has not been taken into account on their pay element (30%) of Basic pay) which is denial of legitimate weightage of the Running element. For example.

Hence it is demanded that in case of Running staff the multiplication factor be taken as 3.0 and thereafter the revised Pay cell should be chosen. The actual example in RB's letter dated 2.8.16 (Annexure "C") taking pre-revised basic pay as Rs. 19930/- (pay Rs. 15730 + GP Rs. 4200) may not yield any difference in the methodology demanding by the Union of that shown in RB's example. But in other cases (different pay other than Rs. 15730) the figure will arrive greater than that Bd's illustrated.

Hence, it is requested to look into the matter so that the Running Staff are not deprived of their legitimate claim.
