Kindly recall the agenda referred above, where Union proposed promotional avenues of Commercial Porters. After detail deliberations it was assured that a certain percentage of posts will be earmarked in Rs.1900/- GP. The matter still is pending.

You are aware that after prolong persuasions ex-contractual men were absorbed in IS i.e. Rs. 1300/ GP. Now, after persuasion they have been given berth in level 1 (7th CPC)Pay Matrix. A good No. of staff of this category superannuated/died during last few year with such poor pay. This goes against natural justice.

The staff absorbed in 15th March 2010 will complete 10 years of service in March 2020. In absence of any avenue of promotion, they will be deprived of MACP which will be another blow to their financial carrier. Union has been engaged with their problems since inception. Unfortunately, there is lack of initiative on the part of the administration.

Now, we would request you to expedite the matter for avenue of promotion of Commercial Porters at the earliest.
